### **Terms & Conditions**

IN CONSIDERATION OF BEING PERMITTED TO EFFECT PURCHASES ON THE APPLICANT'S ACCOUNT(S) UP TO A CREDIT LIMIT WHICH WILL BE DETERMINED BY CSC LED Corp (herein referred to as 'CSC') AT ITS SOLE DISCRETION, THE UNDERSIGNED APPLICANT(S) (herein collectively referred to as the 'APPLICANT') HEREBY AGREES TO THE FOLLOWING TERMS AND CONDITIONS:

- 1. The Applicant shall pay all invoices within thirty (30) days of the invoice date. Accounts not paid within such terms shall be deemed to be overdue and the Applicant agrees to pay administration charges of 1.5% per month (18.0% per annum) on the amount of any overdue balance from the date such balance(s) becomes overdue.
- 2. The Applicant acknowledges that CSC may, at its sole discretion, reduce, refuse, or suspend all credit privileges on the Applicant's account(s) at any time, for any reason.
- 3. A return authorization (RMA) must be obtained before goods may be returned for credit. Restocking charges may apply on all returned goods. Reference must also be made to CSC's original invoice number.
- 4. The Applicant agrees that every invoice and statement of account shall be deemed and treated as authorized and correct unless a written notice to the contrary is received by CSC within fifteen (15) days from date of such invoice or statement.
- 5. The Applicant hereby agrees to pay all costs of collection and/or legal fees incurred by CSC in connection with the collection or recovery of any amount owed by the Applicant to CSC.
- 6. All changes in the Applicant's legal structure and/or ownership will be immediately reported to CSC in writing.
- 7. The Applicant herby authorizes CSC to conduct, or cause to be conducted, all credit investigations on the Applicant and any guarantors as CSC deems necessary, and to divulge credit references to other creditors as requested, with regards to the credit line established and history of payments on account.
- 8. The Applicant hereby authorizes the Applicant's bank and/or its employees, at any time, upon receipt of a written request from either CSC or its representative, to provide a written credit report or reference which details the nature and extent of the Applicant's credit dealings with the Applicant's bank.
- 9. Title to all goods sold or delivered by CSC shall remain in CSC until such goods have been fully paid for and the Applicant hereby grants to CSC a continuing security interest and purchase money security interest in all such goods and their proceeds to secure payment by the Applicant of all its obligations to CSC.
- 10. The Applicant consents to CSC obtaining and disclosing personal information about the Applicant and/or its principals and guarantors, for the purpose of deciding whether to extend credit to the Applicant (the 'Purpose'). The Applicant represents and warrants that it has the authority to grant such consent on behalf of such principals and guarantors. CSC may obtain such information from, or disclose such information to, any credit reporting agency, credit bureau, collection agency, personal information agency, financial institution, bank, any party with whom the Applicant or its principals and guarantors have had or may have financial relation, or any other party on a need-to-know basis for the Purpose. CSC shall keep such information as long as is necessary for the Purpose or as required by law.
- 11. This Application may be executed and delivered by email and, if so executed and transmitted, this Application will be for all purposes as effective and binding as if an originally executed document was delivered.
